ORDER

1. Allotment amounting to INR 223.99 crore of IBRD supported ISGPP-II grant as performance based grant (PBG) component in favour of 1119 qualifying Gram Panchayats for implementation of planned activities for 2017-18 vide Order No. 1197/ISGPP/22F-1(Ff)/15 dated 25.08.2017. The number of qualifying GPs in each district were determined through the Annual Performance Assessment (APA) of 3230 Gram Panchayats, except 112 GPs in the hill area of Darjeeling district, conducted in 2016 by an external independent agency. Subsequently the report on APA 2016 was reviewed and approved by Inter Departmental Programme Steering Committee.
2. In the meanwhile, ISGPP-II has received SFC grant under PBG component from the F.D. of Government of West Bengal for allocation in favour of GPs qualified in APA 2016. Altogether 2037 GPs had qualified for accessing PBG for implementation of planned activities for 2017-18.
3. Now, the undersigned is directed by the order of the Governor to say that the Governor is pleased to accord sanction of **Rs. 1530000000/- (one hundred fifty three crore)** only as SFC grant under PBG component for FY 2017-18 in favour of qualifying GPs across the state as furnished in the table below.

4. Fund is being transferred to the respective designated PBG A/c of DP&RDO of 19 districts. Now, this is to be ensured that GP shall have to utilise their grant for such activities as have been included in approved plan only for financial year 2017-18. The activities which are non-permissible (i.e., the negative list) under the PBG must not be implemented.
5. The District Panchayats & Rural Development Officer shall have to transfer the allocation to the SB account of qualifying GPs as per **Annex-I and Annex-II** by 31 October 2017 without fail and send the undersigned the scanned copy of the bank passbook as proof of grant transfer.
6. Concerned bankers are being instructed accordingly.
