Any application without accompanied with necessary documents will disallow for issuing tender form from this office against this tender notice.

Upon scrutiny of application forms the prescribed tender forms will be issued from this office on **25/05/17** between **1.00 P.M** hours to **3.00 P.M** hours. The cost of Tender Paper is not refundable.

Tender form duly filed in and in scaled envelope will be received on **26/05/17** by **2 PM** and will be opened on **26/05/17** at **3 PM** by the undersigned or his authorized representative in the presence of such tenderers who wish to remain present.

The Tender form must be accompanied by the requisite earnest money deposit in the form of Bank Draft in favor of Prohdan, Bilati Gram Panchayat. The name and address of the tenderer, the name of work and tender no. must be clearly super scribed on the scaled envelope

The rate should be quoted in both figure and words and shall be all inclusive (such as IT, ST, etc.) The tenderers are advised to visit the worksite prior to submission of tender. Once tender is deposited no change of rate shall be allowed

The material should confirm strictly to the P.W.D specification and quantity of work as indicated above is provisionally final. The Gram Panchayat reserves the right to reduced or increased the quantity of work or taken up any part of work for execution departmentally for which no compensation is payable to the supplier/tenderer at any circumstances.

For unexecuted work within the stipulated period the supplier/tender may be asked to pay a penalty ranging from $\frac{1}{2}$ % to $2\frac{1}{2}$ % for every fortnight.

The work shall commence within one week from the issue of the work order and will be carried out under the supervision of the Nirman Sahayak-in Charge/STP concerned. Prior to the commencement of the work the supplier /tender must be in writing communicate the date of commencement of

After completion of the work payment shall be made as per rates approved in the lender and as per measurement recorded in the M.B. /M. Sheet by the STP / Nirman Sahayak, supervising the work and after security verification of the work as may be deemed necessary deduction shall be made from the bill such as IT, ST, surcharge and security money as prescribed by the Government from time to time.
